PARTNER IMPACT

Glen Canyon Conservancy works with a variety of federal, state and local entities to enrich the experience of residents and visitors to our public lands. These partnerships are critical to the Conservancy’s mission.



By far, our greatest impact is providing Information Specialists.

In each of our nine locations (listed below), our Information Specialists not only sell educational products and souvenirs to visitors but are a vital resource for providing information on the history and landscape of the area, as well as giving updates to visitors on weather reports, road conditions and current resource hazards to be aware of, including flash flooding in remote canyons, transportation restrictions for local roads and local search and rescue contacts. (We even provide much-needed restroom services at Navajo Bridge Interpretive Center!) Without us, some of the visitor centers throughout Glen Canyon National Recreation Area would not be open.

NATIONAL PARK SERVICE

Glen Canyon National Recreation Area | Rainbow Bridge National Monument

- Awarded **\$245,000** to more than 350 anglers, **mitigating over 3290 brown trout** in the Colorado River.
- Provided instruction, tackle boxes and fishing rods to over 200 4th graders in the Page School District as part of the National Park Foundation's **Junior Ranger Angler initiative** to get kids in the outdoors.
- Provided assistance and career guidance for 2 participants of the **LeChee Youth Career Exploration Program** to educate Native American youth on National Park Service careers and opportunities.
- Provided funding for the expert material analysis of **archeological objects** in the park's museum collection.
- Facilitated river travel for 18 members of a **Multi-agency Technical Work Group**, which makes important recommendations impacting the Colorado River Basin.
- Provided funding for ten participants in a park-wide **Hazard Communications Plan Workshop**, ensuring that the park is adhering to all policies and regulations related to hazard communications.



- Funded new **outdoor educational signs** at Navajo Bridge and Lonely Dell Ranch.
- Supported multiple **tribal consultations** between Native American elders and National Park Service leadership on a variety of park initiatives by providing usage of GCC's Talbot boat and boat captain.
- Alongside the NPS, conducted **30 classroom visits** and boat trips, deepening more than 200 students' understanding of public lands and the resources they conserve.
- Provided promotion, funding and on site support of the **Love Your Lake** beach cleanup.
- Provided promotion and on site support to more than 200 visitors for the **Annular Eclipse Event** at Carl Hayden Visitor Center.

BUREAU OF LAND MANAGEMENT

*Grand Staircase-Escalante National Monument
Canyons of the Ancients National Monument | Vermilion Cliffs National Monument*

- Assisted in selection of the **Artist in Residence** ambassador to the landscape, an ongoing program that connects visitors with the Grand Staircase through artist workshops.
- Provided rewards for **youth citizen science bird monitoring efforts** in the Kanab and Fredonia area at local schools.
- Selection and award of district-wide **environmental awareness poster campaign**.
- Promotional outreach of monument initiatives and events in both Grand Staircase and Canyons of the Ancients, including guided hikes, cultural demonstrations, citizen science activities and more.



STATE & LOCAL

Coconino County | City of Page, Arizona



- Co-hosted the monthly **Glen Canyon Lecture Series** in partnership with Page Public Library, bringing in speakers to present on topics ranging from nature to cultural history for approximately 30 attendees per month.
- As members of the organizing committee for **Page Attacks Trash**, GCC helped orchestrate the promotion design contest, event planning and volunteered with cleanup.
- Adopted a section of the **Page Rim Trail** to continue beautification of city assets through cleanup activities
- Supported the **Regional Trails Alliance** program in partnership with the Coconino County to map and promote the available trails in the area.



POWELL MUSEUM — & ARCHIVES —

More than four years after suffering a devastating flood, the Powell Museum & Archives reopened to the public over Labor Day weekend. The new exhibits feature a wealth of area information highlighting Page and the surrounding area's unique history.

Exhibits include Explorers of the Colorado, Geology of the Grand Staircase-Escalante Monument, Manson Mesa, History of Page, History of Lake Powell, River Running and Dinosaurs of the Kaiparowits in partnership with Bureau of Land Management.



The museum is now also the forever home of the famous Glen Canyon relief map originally housed at Glen Canyon Dam. This labor of love would not have been possible without the support of so many community members, businesses and organizations.

WHERE WE ARE NOW

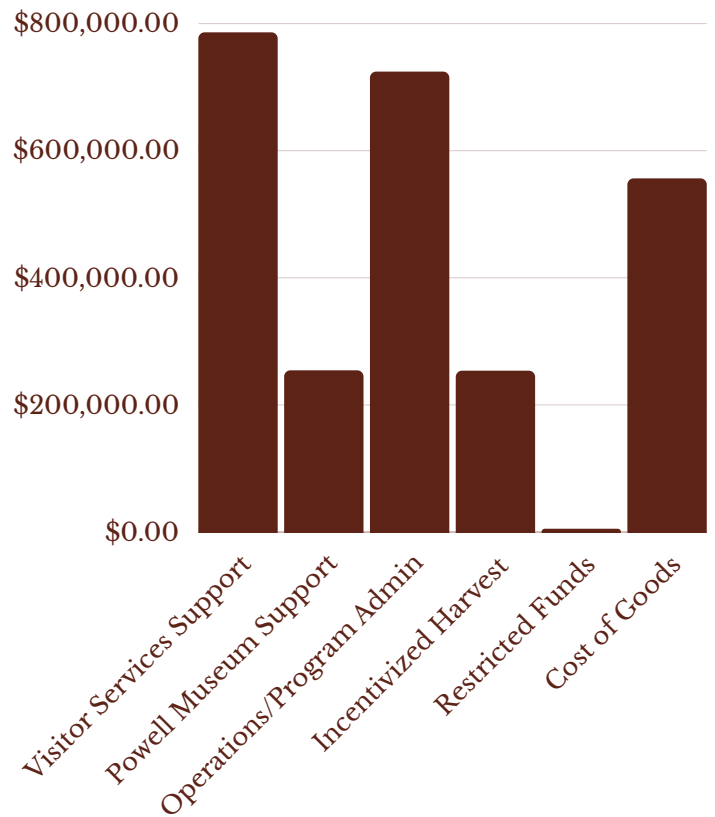
Below is a summary of GCC’s financials, as prepared by our accounting firm hired mid way through 2023. The organization is still recovering from disruptions to operations due to COVID and shutdowns related to that. In addition, the Emergency Injury Disaster Loan taken out for the renovation of the Powell Museum remains a factor. However, we have seen a positive trend in reducing losses and controlling costs and expect to continue that trend into 2024. GCC just completed a 2021 Financial Audit and a 2022 Review.
